

**MEMORANDUM OF UNDERSTANDING ON ENHANCING THE COOPERATION  
BETWEEN  
THE SUPREME PEOPLE'S PROCURACY  
OF THE SOCIALIST REPUBLIC OF VIET NAM  
AND  
THE SUPREME PROSECUTORS' OFFICE OF THE REPUBLIC OF KOREA  
FOR THE PERIOD OF 2019-2022**

The Supreme People's Procuracy of the Socialist Republic of Viet Nam and the Supreme Prosecutors' Office of the Republic of Korea (hereinafter referred to as "the Parties");

Implementing the Agreement on Mutual Cooperation between the Supreme People's Procuracy of the Socialist Republic of Viet Nam and the Supreme Prosecutors' Office of the Republic of Korea signed on June 23, 2003;

Intending to strengthen the cooperation between the Parties, and to contribute to enhancing the understanding, friendship and comprehensive cooperation between the Socialist Republic of Viet Nam and the Republic of Korea;

Have reached the following understandings:

**Article 1  
Principles of cooperation**

The Parties will cooperate within their respective jurisdictions and competencies, subject to their respective domestic laws and international obligations

**Article 2  
Areas of cooperation**

For the purpose of implementing this Memorandum of Understanding, the Parties will cooperate in the following areas:

1. The Parties will organize seminars annually in turn and conduct researches on relevant topics. The Parties will discuss and agree upon the details including dates, places and topics in advance.

2. The Parties will exchange materials related to seminars and other documents and information as mutually discussed and determined.

**Article 3

**Article 4  
Language**

Information and documents relating to the implementation of this Memorandum of Understanding, if not in the Vietnamese and Korean language, will be accompanied by a translation in English.

**Article 5  
Expenses**

Either Party will bear its own cost arising from the implementation of this Memorandum of Understanding, unless otherwise mutually agreed by the Parties in each specific case.

This Memorandum of Understanding will come into effect on the date of its signature.

Signed in Hanoi on 29 January, 2019 in 2(two) original copies, each in Vietnamese, Korean, and English; all three texts being equally authentic. In case of any divergence in interpretation, the English text will prevail.


