

**Memorandum of Understanding on Cooperation
between The Supreme People's Procuracy of the
Socialist Republic of Viet Nam and the Director
of Public Prosecutions of the Kingdom of
Denmark**

The Supreme People's Procuracy of the Socialist Republic of Viet Nam and the Director of Public Prosecutions of the Kingdom of Denmark (hereafter referred to as "the Parties"), for the purpose of further strengthening cooperation and traditional friendship between the Supreme People's Procuracy and the Director of Public Prosecutions, on the basis of the mutual respect for sovereignty, non-interference in each other's internal affairs, equality, mutual benefit and cooperation have reached the following Memorandum:

Article 1

The Parties shall strengthen and develop their cooperation within the framework of their respective functions and financial means, in compliance with national law and international commitments of their respective states.

Article 2

1.
The Parties may, after mutual agreement, cooperate in exchanging official working visits, organising seminars and workshops with a view to exchanging experiences and discussing issues of common interest.

2.
The Parties may upon request exchange copies of relevant legal publications, research and information about their work.

3.

The Parties shall extend cooperation in training and education of the prosecution services of the Socialist Republic of Viet Nam and the Kingdom of Denmark.

Article 3

1.

For the purpose of implementing this Memorandum, the Parties shall maintain direct contacts or use diplomatic channels.

2.

For the effective implementation of this Memorandum, the Parties shall assign their central authority as follows:

Article 4

Expenses for cooperation activities mentioned in this Memorandum shall be borne according to mutual agreement and understanding.

Article 5

Documents forwarded within the framework of this Memorandum shall be drafted in English or shall be accompanied by a translation into English.

Article 6

The parties will according to the principle of mutual understanding and mutual respect and through consultations solve any problems arising in the course of implementation of the Memorandum.

Article 7

This Memorandum may be amended by written agreement of the two Parties. The amendments shall be considered an integral part of this Memorandum.

Article 8

1.
This Memorandum shall enter into force on the date of its signature for an infinite term.

2.
Each Party can terminate the Memorandum at any time by giving written notice of termination to the other party. The Memorandum shall be terminated on the thirtieth day after the date of receipt of the said notice.
